DEPARTMENTAL WEEKLY REPORTS

December 10, 2010

Electric

The contractor has completed the underground cable bores along Radcliffe Drive. Approximately 5,500 feet of underground primary was pulled, with four sectionalizing boxes and one new pole installed. The line crews have started terminating the cables. This project along with the underground cabling completed last summer along Lafayette Road will bring much more reliability to the customers in Nottingham Green and Nottingham Manor.

In a concerted effort, engineering, line crews, and electricians worked on troubleshooting issues with a circuit which feeds industrial customers on Bellevue Road. After removing a feeder breaker, dismantling substation switchgear, and extensive testing of the current transformers and a relay, it was discovered that the relay operated correctly, but because of the nature of a fault that required this attention, the readings on the relay were misleading.

Engineering attended a DEMEC sponsored seminar about load shedding during peak times. Voltage reduction and demand curtailment from customer participation was explored. Global participation from DEMEC members should enhance economies of scale and the buying power of load reduction devices.

Police

A 15-year old suspect has been identified as the graffiti vandal using the tag "EDGE". The tag is painted at many locations of the east and south side of Newark as well as in county and state police jurisdiction. The juvenile has been charged and another graffiti suspect should be arrested in the near future.

On Monday, December 6th, at 9:25 a.m., officers responded to a report of suspicious persons on North Fawn Road. A resident observed two males in the rear of a house touching the window ledge of a neighbor's house. The resident called out to the suspects who stated they were looking for someone. The resident called the police with a description of the suspects. Corporal Marsillii searched the area and found the two suspects in the area of Patrick Henry Court. The suspects confessed to attempting to break into the house. They also confessed to another burglary in the area. This is a good example of how important it is for residents to call the police and report any suspicious activity no matter how minor it may seem.

On Tuesday, December 7th, unknown suspect(s) broke a basement window and entered a house on the 200 block of Cullen Way. The suspects stole thousands of dollars worth of jewelry. It appears that the incident occurred between 11:30 a.m. and 2:00 p.m. This is the second burglary to occur at the Hunt at Louviers in the past two weeks. In both

incidents, entry was made through a basement window. Neighbors that were home at the time of the incident reported that they did not see or hear any suspicious activity.

On Tuesday, December 7th, a search warrant was executed at a local business regarding counterfeit National League Football clothing being sold. Over 300 counterfeit jerseys were recovered from the business. An additional 69 counterfeit jerseys were recovered at the suspect's residence. The suspect purchased the jerseys from China for \$20 each and then sold them for \$25 to \$65. The suspect cooperated with the investigation and the facts were reviewed by the Attorney General's Office. The trademark infringement will be handled civilly.

<u>Administration – Charlie Emerson</u>

I participated in a conference call last Friday with representatives of Pennoni to discuss lighting matters relating to the Pomeroy Trail.

I committed a good amount of time working with the developers for the Ivy Hall Apartment addition and Marrows Court on items relating to required landscaping and the surety bond (warranty) requirements.

On Monday I submitted a Pre-Application to the Delaware Land and Water Conservation Trust Fund (DTF) grant administrator for funding support for the Redd Park trail improvements project. We're in the second year of the four (4) phase trail relocation and improvements project. We have partnered with the Delaware Trail Spinners and the Delaware State Parks Trail Crew to evaluate the existing trail system, relocate and realign certain routes and construct more sustainable trails which includes several footbridges that cross over Jenney's Run and some of its feeder tributaries. Two of the four phases of the project are complete. During phases one and two more than 1,300 volunteer hours were committed to the project.

I'm preparing a project status report and request for reimbursement for a DTF funded parks project. We received matching grant funding (50% match) to replace four (4) old spiral slide units at these park sites: Devon, Handloff, Stafford and Kells. Installation was completed this fall.

Paula gathered supplies and attended the Heritage Month celebration at the After Care program at Downes School. The kids were divided into four countries (South Africa, China, Germany and Guatemala) and competed in various activities and a world cup soccer game during the celebration.
