**SUBJECT:** Fatal Collision Victim Identification

The Newark Police Department continues to investigate the fatal three car collision that occurred at the intersection of Papermill Road and Louviers Drive on June 23, 2010. The occupants of the black Honda were Marcella Scally, 53, of Newark and Meredith Taggart, 41, of New Castle. Ms. Scally was pronounced deceased at the scene and Ms. Taggart remains at Christiana Hospital in critical condition. **SUBJECT: Fatal Collision** 

The Newark Police Department is investigating a fatal three car collision that occurred at the intersection of Papermill Road and Louviers Drive at 1234 hours this date. The victim was exiting the Shoppes of Louviers Shopping Center, in a black Honda, when it was struck on the left side by a north bound white Jeep Wrangler. These vehicles came to a stop in the intersection after colliding with another car that had been in a south bound lane.

The operator of the black Honda was pronounced deceased at the scene of the crash. A passenger in the Honda was taken to Christiana Hospital with head injuries. The
