**SUBJECT: Two Arrested for residential burglaries**

The Newark Police Department has identified and arrested two suspects for their involvement in local burglaries after receiving information from the New Castle County Police Department linking them to the crimes.

On November 30<sup>th</sup>, 2010 Newark Police investigated a daytime burglary which occurred in the 200 Block of Walker Way in the Hunt at Louviers development. In this burglary the suspect(s) gained entry to the residence by breaking a basement window and once inside stole a quantity of jewelry and prescription medication.

On December 7<sup>th</sup>, 2010 Newark Police investigated a second daytime burglary which occurred in the 200 Block of Cullen Way, also in the Hunt at Louviers development. In this burglary the suspect(s) also gained entry to the residence by breaking a basement window and once inside removed a quantity of jewelry and US Savings Bonds.

Investigators have linked Jessie McCumber-Price to both the burglary in the 200 Block of Walker Way and the second burglary in the 200 Block of Cullen Way.

Garnell Brunson has been linked to the burglary in the 200 Block of Cullen Way.
