SUBJECT: Cell Phone App Leads Police to Armed Robbery Suspects

The Newark Police Department has credited a mobile phone application with leading police to the location of four suspects following an armed robbery in Newark on May 21st, 2011.

At approximately 2:20 am on that date a group of fifteen subjects were attending a small party in a detached garage in the unit block of Annabelle Street when they allowed the four defendants to enter. Shortly after, the defendants closed the garage doors and one defendant, later identified as Joseph Thomas, displayed a handgun. The defendants then forced ten of the victims to turn over property including wallets, cell phones and cash. One subject was repeatedly punched and kicked by the defendants after he failed to turn over property. The four defendants then fled the garage on foot. None of the victims, all college age, were hurt during the incident.

Shortly thereafter, responding officers learned that one of the stolen phones was equipped with a GPS tracking device. Using computer software officers were able to track the movement of the phone and the four defendants were located travelling in a vehicle in the University Plaza Shopping Center. All four were then taken into custody without incident. Stolen items, including the GPS equipped phone, were found in the vehicle linking the four to the robbery and officers also recovered a loaded .38 cal. handgun used during the robbery.

Officers determined that the four in custody and their vehicle matched the description of a car jacking incident several hours earlier in New Castle County Police jurisdiction and they were later linked to that crime.
