SUBJECT: Newark Man arrested for Burglary of Embassy Suites

On October 28th, 2011 the Newark Police Department arrested 22 year old Kyle Jones of Newark for a Burglary and Theft which occurred at the Embassy Suites Hotel on September 17th, 2011. The initial investigation was falsely reported as an armed robbery; however, investigators have learned that this report was factually inaccurate. During the incident Jones gained access to a secured area of the facility and removed an undisclosed amount of currency from a cash drawer. It has been determined that Jones is an acquaintance of the reporting victim and the investigation is ongoing.
