Update: Politakis Apprehended

The Maryland State Police apprehended Brian Politakis late last evening at 40 North Navaho Trail in Elkton, MD. MSP responded to that address to search for Politakis after NPD Detectives disseminated a wanted poster to area law enforcement agencies. Politakis was apprehended without incident and is currently held in the Cecil County Detention Center awaiting extradition back to Delaware.

SUBJECT: NPD Seek Public's Assistance Locating Elkton Man Wanted for Robbery

Newark Police are searching for 28 year old Brian E. Politakis of Elkton, MD for his involvement in a strong armed robbery, which occurred at approximately 10:45pm on January 20th, 2014 in the parking lot of 630 South College Avenue in the City of Newark.

During the incident, a 34 year old female contacted Politakis and 23 year old Lindsey Frederick of Newark and arranged to purchase prescription narcotics from them in the parking lot. When Politakis and Frederick arrived, Politakis robbed the 34 year old female, stealing her purse and money.

Detectives quickly identified Politakis and Frederick. Frederick was located and arrested on January 31st, 2014. Frederick was committed to Delores Baylor Women's Correctional in lieu of \$4,200 bond. Detectives have obtained arrest warrants for Politakis whose last known address was in Elkton, Maryland. Detectives are asking for the public's assistance in locating Politakis, who is known to frequent motels in Maryland and Delaware.
