SUBJECT: NPD Arrests Two for Drug Charges

On March 3rd, 2015 at approximately 10:30pm, NPD responded to the 7-Eleven (235 East Delaware Ave, Newark, DE 19711) for a check on the welfare of two subjects who were slouched over in a vehicle. NPD officers arrived and contacted Stefano Saienni, who was sitting in the driver's seat, and Bradley Hooks, who was sitting in the passenger's seat.

NPD officers discovered 171 bags of heroin, a small amount of methamphetamine pills and \$260 USC on Stefano Saienni. Two bags of heroin were discovered on Bradley Hooks.

Both defendants were taken into custody without incident and transported back to NPD.

Hooks was committed to Howard R. Young Correctional Institution in lieu of \$3,200 cash

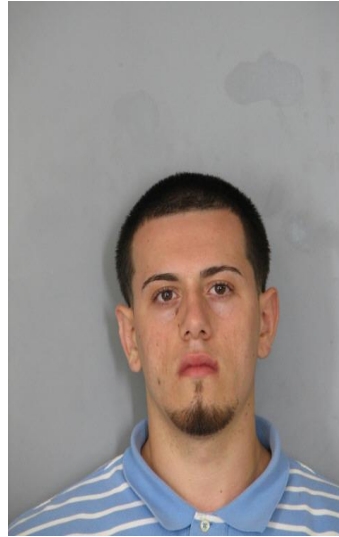

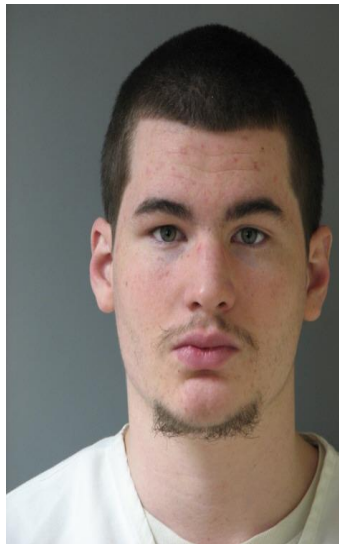
