## **Drug Deal Robbery – Arrest**

August 10, 2016 – On May 27, 2016 a 15 year old male victim came to the Newark Police Station to report he had been robbed while trying to buy an X-box in the area of Mathew Flocco Dr., Newark, DE. Based on the investigation it was learned that the youth had actually been trying to buy marijuana from an acquaintance he had met the previous day.

Newark Police detectives were able to trace vehicle and phone information to an apartment in Brookside, Newark, DE. On July 29, 2016, detectives served a search warrant at the Brookside apartment and found items associated with the robbery. The items found included a silver BB gun, a black Colt revolver, and illegal drugs. Brothers, Brandon Silva (21) and Brian Silva (19) were arrested and charged for their roles in the robbery and also for items found in their possession during the execution of the search warrant. Both Silva brothers were committed to the Howard R. Young Correctional Institution in lieu of bail. A third unknown suspect, described only as possibly Hispanic, is still at large.
