



Senior or Disabled Assessment Exemptions Deadline Approaching

If you turn 65 before July 1, or if you are currently disabled, you may be eligible for a property tax exemption from both New Castle County and the City of Newark. In addition, senior citizens may also qualify for an annual \$400 school tax credit. The deadlines to apply for these tax breaks are coming up shortly:

Senior School Tax Credit (April 30 Deadline): Application: http://www.nccde.org/DocumentCenter/View/237.

County Tax Credit (June 1 Deadline): Disability Exemption Form: http://www.nccde.org/DocumentCenter/View/232; *Over* 65 Exemption Form: http://www.nccde.org/DocumentCenter/View/233.

There are income limitations to these programs. Once a Newark resident qualifies with the County for a property tax exemption by completing and submitting the aforementioned applications, their future City of Newark tax bills will reflect their new exemption.

Since the County provides tax information to the City of Newark, there is nothing else needed from Newark residents once they complete their application.
