SYNOPSIS: The Newark Police Department Traffic Response Unit responded to a report of a multiple vehicle serious personal injury collision this morning on the Christina Parkway (Route 4), just east of Elkton Road. The collision occurred shortly before 6:00 a.m. when a 1997 Mitsubishi SUV operated by Andre Lamont Evans (28 yoa) of King William Street, Newark, Delaware, crossed the center line while travelling westbound on Rt 4 (Christina Parkway) on the railroad overpass east of Elkton Rd. The Mitsubishi sideswiped the driver's side of a 2006 Honda Civic driven by Theresa Bartlett (34 yoa), with passenger Glenn Bartlett (57 yoa) of Kirksmill Road in Nottingham, PA which was eastbound in the left hand lane of the Christina Parkway. The Mitsubishi continued westbound and sideswiped the passenger side of an eastbound 1993 Honda Civic driven by Ryan Morgan (31 yoa) of Den Road in Lincoln University, PA. Morgan attempted to avoid the Mitsubishi by driving into the westbound lanes. The Mitsubishi then struck an eastbound 2002 Chevrolet Silverado pickup truck head-on operated by Leonard Kyle (43 yoa) of Blacksnake Road in Elkton, MD. The roadway was closed for approximately 2 ½ hours.

Four were transported to the Christiana ER for treatment. Charges have not yet been filed. The investigation of the collision is ongoing. Witnesses to the collision are requested to contact M/Cpl. Curtis Davis of the Newark Police Department Traffic Response Unit at (302) 366-7110 ext. 106.
