SUBJECT: Juvenile Charged with Falsely Reporting Kidnapping

The 13 year-old female who made a fictitious report of a kidnapping and attempted sexual assault on June 9 has been charged with a criminal offense. On June 15, the juvenile was arrested on one count of Falsely Reporting an Incident. She was released to her parents on an unsecured bond of \$1,000 with several conditions, including pre-trial supervision, a mental health assessment, and a 6:00 p.m. curfew.

SUBJECT: Kidnapping Allegation a False Story

The June 9 reported kidnapping and attempted sexual assault alleged to have taken place at the College Square shopping center did not actually occur. The investigating detective discovered discrepancies in the victim's story. After being confronted with the inconsistencies, the 13 year-old female admitted she concocted the account of the kidnapping. The actual story is the girl was trying to conceal visiting her boyfriend without her parents' consent.

Summary:

On June 09, 2009, at approximately 1713 hours, the victim, a 13 year old female, was walking through the rear of the Pathmark parking lot located at 100 College Square Newark, De. The female victim was then approached by a Hispanic male, 5'06", 20-25 years of age, short spiked hair, with a tattoo under his left eye, and facial acne. The male suspect was driving a black four door sedan with heavily tinted windows, chrome rims displaying an unknown Pennsylvania registration. The male suspect grabbed the female victim and forced her into the vehicle. The suspect then left the area with the victim. While driving the suspect attempted to sexually assault the victim. The female was able to flee the vehicle unharmed and contacted police.

The victim sustained minor injury and no medical treatment was required.
