2. NOTICE TO BIDDERS

- A. The Bidder shall acknowledge receipt of this addendum with their submitted proposal. Failure to do so may disqualify the Bidder.
- B. The date for questions and receipt of bids remains unchanged by this addendum.
- C. This addendum shall serve to answer questions submitted to date for this contract.

3. REVISIONS AND CLARIFICATIONS

- A. The number of days for the project to be completed after issuance of NTP is hereby revised from 120 days to 30 days. This change is on the attached Proposal which shall be used for submitting bids.
- B. The scope to reset the VFW building roof drains is to excavate from the parking lot, starting at the outlet ends of the pipes, along the drainpipe to a point where the pipe may be reset with positive drainage. The pipe shall be cut and new drainpipe shall be attached and set to provide positive drainage and outlet flush with grade.
- C. There are currently four existing wheel stops in the VFW parking lot. The one newer wheel stop shall be removed for repaving operations and reinstalled when repaving is finished. Five new wheel stops shall be furnished and installed for a total of six wheel stops in the finished parking lot. The other three existing wheel stops shall be removed and returned to the City.
