Question 1:	Can the prevailing wage sheet for this project be provided?		
Response 1:	This is included in the bid package on the City's website under Attachment 3 (the very end of the document).		
Question 2:	Confirming this project is federally funded and that the sam.gov registration requirement applies to primes and subcontractors?		
Response 2:	This project is funded through the State of Delaware Community Reinvestment Fund (CRF). There are no federal dollars in this project. However, per City policy, all primes and subcontractors will go through a check on sam.gov to ensure they have no exceptions declared against them by the Federal Government. Sam.gov registration is not required to complete this check.

The sign-in sheet is attached. The purpose of this meeting was to provide an opportunity for prospective bidders to ask questions regarding the project. Provided below is a summary of the pertinent discussion items.

BIDDING ADMINISTRATION INFORMATION

- A. Sign In Sheet: Please sign in.
- B. Bid Opening: Tuesday November 18, 2025 at 2:00 pm.
- C. Addenda: An addendum will be issued to address questions and clarify issues discussed at the prebid meeting. The addendum will be emailed to all attendees listed on the sign in sheet AND uploaded to the City of Newark's website.
- D. Questions: Submit questions regarding the bidding process via email to <u>contracts@newark.de.us</u> no later than 5:00 p.m. on Wednesday November 12, 2025.

SCOPE OF WORK

A. George Wilson Center Improvements:

1. Base Bid:

- Site and facility accessibility improvements, including exterior ramp replacement.
- Complete renovation of existing toilet rooms, including correction of floor slab elevations, installation of new plumbing fixtures.
- Addition of one all-gender restroom, and accessory upgrades.
- General building improvements including flooring replacement, interior finishes replacement, and exterior finishes replacement.
- Plumbing, electric, and HVAC improvements required for improvements, including upgrades
 to existing lighting, replacement of plumbing fixtures, relocation of existing hot water
 heaters, exhaust fans, and grease trap and new piping, venting, and insulation as required to
 ensure complete operational systems.
- 2. **Alternate 1**: Remove and dispose of existing VCT flooring and vinyl wall base and prepare floor to receive new finish, then provide and install new epoxy resin flooring with 4" integral cove base in classroom #004 and corridor #001.
- 3. Alternate 2: Prepare and paint all walls, prep and paint all metals handrails and railing, provide and install new rubber stair treads with integral risers, provide and install coordinating rubber flooring at landings in existing stair A and B (both levels).
- 4. **Alternate 3:** Prepare and paint the existing areas of stucco on the east and west exterior facades.
- 5. **Fire Alarm System Modification**: Removal and replacement of two smoke detectors, two pull stations, two horn strobes, and one strobe as well as installation of two heat detectors, all programing and electrical inspection by Marmic Fire and Safety.
- B. State of Delaware Prevailing Wage Rates are required.



- C. Anticipated Notice to Proceed is January 1, 2026, although may be as soon as mid-December. Contract duration is 150-days. Anticipated completion on or before May 31,2026 or mid-May with early NTP. Liquidated damages are set to \$500 per day.
- D. Unit pricing shall include all incidental costs necessary to complete the scope of work item. This includes, but is not limited to, equipment, manpower, profit, overhead, materials, restoration, etc.
- E. Access and Laydown Parking area adjacent to the building may be used as laydown. Access to building must be maintained at all times.
- F. Permits Commercial renovation building permit will be required by the City of Newark. Permit fees are waived. City of Newark Contractors License is also required for all contractors working onsite.

QUESTIONS AND ANSWER SESSION

Question 1:	Has a hazardous materials study been completed?
Response 1:	Yes, an Environmental Assessment Report is included as Attachment 2 of the project manual.
Question 2:	Are the prevailing wage rates required for the project provided?
Response 2:	Yes, prevailing wage rates are included as Attachment 3 of the project manual.
Question 3:	If notice to proceed is issued early will the anticipated completion date change?
Response 3:	Yes, contract duration is set to 150 days. Contract completion will be 150 days from NTP.
Question 4:	Are mechanical improvements part of a separate contract?
Response 4:	No, all work is part of a single contract with the City of Newark.
Question 5:	Are designated subcontractors included in the contract.
Response 5:	No, contractors and free to use their own subcontractor but they must be licensed within the City of Newark.
Question 6:	Are there designated work hours or restrictions for construction?
Response 6:	The City's noise ordinance restrict work to 7:00 a.m. – 9:00 p.m. on Monday through Saturday, and 9:00 a.m. – 9:00 p.m. on Sunday.
Question 7:	Will there be any additional walkthroughs?
Response 7:	Submit question electronically. An additional site preview can be coordinated.
