BOARD OF ADJUSTMENT

- AUTHORITY:** Newark City Code, Chapter 32, Zoning, Article XIX, Section 32-62 to 32-72; Delaware State Code, Title 22, Section 321 to 331
- MEMBERSHIP:** Five members.
- APPOINTMENT:** Four members appointed by Mayor with consent of Council; one member appointed by Mayor with consent of Council to serve as chairperson whose term shall be at the pleasure of the Mayor.
- TERM:** Four members, four years; chairperson, at pleasure of Mayor.
- PAY:** None.
- RESTRAINTS:** Members shall have knowledge and experience in urban and rural development problems. No member shall be, at the time of their appointment, a candidate, candidate-elect for, or incumbent of any elective public office.
- FUNCTIONS:** To hear and decide appeals where it is alleged there is an error in any order, requirement, decision or determination made by the Building Inspector in the enforcement of Chapter 32, Zoning, Newark City Code.
- To authorize, upon appeal in specific cases, such variances from the terms of Chapter 32, Zoning, as will not be contrary to the public interest where, due to special conditions, a literal enforcement of the provision of Chapter 32 will result in unnecessary hardship, and so that the spirit of the Chapter shall be observed and substantial justice done.
- To authorize such variances from the terms of Chapter 32 as will not be contrary to the public interest up on receipt of paper transmitted by the Building Inspector pursuant to Article XX, Section 32-75 (Special Provision Applicable to George Read Village), without the formality of an appeal; provided, however, that notice to all parties in interest shall be given in the same manner as upon hearing of an appeal.
- HEARING NOTICE:** Published in newspaper at least ten (10) days before date of hearing. Direct mail notice to applicant and counsel or representative of record and registered owners of next five properties adjoining or adjacent, in each direction, to the property upon which the appeal centers.
- MEETINGS:** Third Thursday of each month at 7:00 p.m.

BOARD OF BUILDING, FIRE, PROPERTY MAINTENANCE AND SIDEWALK APPEALS

- AUTHORITY: Newark City Code, Chapter 7.

- MEMBERSHIP: Five members and two alternates, one of whom shall be selected by membership to serve as chairperson.

- APPOINTMENT: Appointed by Mayor with consent of Council.

- TERM: Five-year terms.

- PAY: None.

- RESTRAINTS: None.

- BOARD REPORT REQUIREMENTS: None.

- FUNCTIONS: To decide upon appeals from a decision of a City official regarding the application and interpretation of Chapter 7 (Building), Chapter 14 (Fire), Chapter 17 (Property Maintenance) and Chapter 26 (Streets), Article III (Sidewalks). The application for appeal shall be based on a claim that the true intent of the Code or the rules legally adopted hereunder have been incorrectly interpreted, the provision of this Code do not fully apply, or an equally good or better form of construction is proposed. The Board shall not have the authority to waive requirements of the Code.

- HEARING NOTICE: To appellant or their representative. Agenda and notice posting shall be a minimum of seven (7) days in advance.

- MEETINGS: The Board meets upon notice of the chairperson within ten (10) days of the filing of an appeal or at stated periodic meetings if warranted by volume of work.

AUTHORITY: Newark City Code, Chapter 2, Article VI, Sections 2-69 to 2-70, (Ordinance 16-24, 8/8/2016)

MEMBERSHIP: Eleven members: one from each District and five at-large (with at least one from Housing Authority, one from the business community, and one from non-profit).

APPOINTMENT: Six by Council from districts; five by Mayor with Council approval.

TERM: Three years.

PAY: None.

RESTRAINTS: None.

BOARD REPORT

REQUIREMENTS: Recommendations to be submitted to Council for approval. Recommendations for funding agencies are submitted to Council for budget consideration via the Finance Department.

FUNCTIONS: Community Development: To consider requests for funding under Act for the development of viable urban communities by providing decent housing, suitable living environments, and expanding economic opportunities principally for person of low- and moderate-income.

Specific objectives:

- Elimination and preventions of slums and blight;
- Conservation and expansion of the nation's housing stock;
- Elimination of unhealthy and unsafe conditions;
- Expansion and improvement of community services;
- More rational utilization of land;
- Reduction of the isolation of income groups;
- Historic preservation;
- Review findings of Housing Field Survey and evaluate same to make recommendations through the Planning Commission to Council;
- Collect information to help determine what housing types are needed for elderly and low-income families.

Revenue Sharing: The Committee sets applications and proposal guidelines for agencies applying for City Revenue Sharing funds. The Committee reviews proposal submitted by agencies, establishes public hearing decision making processes. Recommendations are forwarded to Council.

MEETINGS: Public hearing required. Other meetings on call of chairperson.

DIVERSITY AND INCLUSION COMMISSION

- AUTHORITY:** Newark City Code, Chapter 2, Article XV, Sections 2-168 to 2-172, (Ordinance 21-12, Amendment I, 4/26/21)
- MEMBERSHIP:** Seven members.
- APPOINTMENT:** One appointed by Mayor and one appointed by each Councilmember.
- TERM:** Initial appointments of Mayor and Districts 3, 5, and 6 Councilmembers shall have terms that expire in even numbered years. Appointments by Councilmembers in Districts 1, 2, and 4 shall have terms that expire in odd numbered year. Thereafter, all terms shall be for two years.
- PAY:** None. Members shall be reimbursed for reasonable expenses subject to travel and reimbursement procedures of the City.
- RESTRAINTS:** A conflict of interest may exist when the interest or concerns of any member of the Diversity and Inclusion Commission may be seen as competing with the interest or policy of the Diversity and Inclusion Commission. Any possible conflict of interest shall be brought to the attention of the Diversity and Inclusion Commission by the member concerned. When any such conflict of interest is relevant to a matter requiring action by the Diversity and Inclusion Commission, the impacted member shall call such conflict to the attention of the Diversity and Inclusion Commission and shall not vote on the matter. When there is any doubt as to whether a conflict of interest exists, the Diversity and Inclusion Commission member shall seek the advice of the city solicitor or an advisory opinion from the City's Board of Ethics.
- BOARD REPORT REQUIREMENTS:** Shall keep summary minutes. Shall file an annual summary to Council in the first quarter of the following year.
- FUNCTIONS:** The Diversity and Inclusion Commission is to provide advice and recommendations to Council and City staff in regard to the following:
- Recommend strategies to achieve Newark's vision to be an inclusive community that embraces diversity and enables and supports different lifestyles by encouraging cooperation, tolerance and respect among and by all persons who come in contact with the City of Newark, including residents, students, visitors, employers and employees.
 - Assist the city and the community to eliminate and prevent all forms of discrimination, hate or bias.
 - Act as conduit for complaints in the area of diversity, equity and inclusion. Any related complaints about city staff will be transmitted to the city manager for investigation and follow-up in accordance with city policy.
 - Recommend methods to improve diversity recruitment and retention efforts at all levels of city government including council, boards/commissions, and staff.

DIVERSITY AND INCLUSION COMMISSION

(continued)

- Provide education regarding the community's overall diversity.
- Recommend effective strategies for improved public engagement and methods to remove or reduce barriers to improve access to city services for our diverse population.
- Recommend areas for investment where needs are greatest, addressing root causes of inequities and lack of access to more smartly allocate our public resources.
- Recommend opportunities for community partnerships as a strategy to better understand and address equity impacts throughout our city.
- Facilitate the building of relationships with under-served and underrepresented communities and serve as trusted messengers to the community at large.
- Prepare an annual report to council on the previous year's activities of the commission and the forthcoming year's goals.
- Perform such other duties as the mayor and/or city council may direct.

The Diversity and Inclusion Commission shall have the authority to form working groups or subcommittees on specific topics that can meet separately from the main commission and report back during regular meetings. These working groups and subcommittees may include additional people who are not appointed members of the Diversity and Inclusion Commission to add additional viewpoints or subject matter expertise. All working groups or subcommittees shall conform to Delaware FOIA regulations. The number of simultaneous working groups or subcommittees may be limited by the ability of staff to provide adequate administrative support.

MEETINGS:

Once each quarter-year at times and places of its choosing in compliance with the Delaware Freedom of Information Act and Section 2-5.1 of City Code. Four members shall constitute a quorum.

AUTHORITY:	Newark City Charter, Section 1002.2; Newark City Code, Chapter 10, Article I, Sections 10-1 to 10-8
MEMBERSHIP:	Seven members.
APPOINTMENT:	Appointed by Council, with one member appointed from each of the six Districts and one at-large.
TERM:	Three-year terms.
PAY:	\$180.00 for each registration and Election Day.
RESTRAINTS:	Each member shall be a citizen of the United States and shall have resided within the geographical boundaries of the City for one year next preceding their appointment. Mayor and members of Council shall not be eligible for appointment to the Board.
BOARD REPORT REQUIREMENTS:	Certification of the results of the election to each person elected and to the Council.
FUNCTIONS:	Conducts all elections and referendums. Has full power and authority to make and adopt rules to carry out the purposes of the Code, the Charter, and the Constitution and laws of the State of Delaware. Shall establish guidelines which shall enumerate the duties of the Board and election officials and the procedures for implementing them. Any member of the Election Board shall be deemed qualified to administer oaths as required by the provisions of the Code regarding absentee registration and absentee voting.
MEETINGS:	The Board shall meet annually on the last Saturday in January and organize by electing one of its members president.

- AUTHORITY:** Newark City Code, Chapter 2, Division 7, Board of Ethics, Sections 2-97 to 2-97.20
- MEMBERSHIP:** Seven members.
- APPOINTMENT:** Appointed by Council, with one member being appointed from each of the six Districts and one at-large.
- TERM:** Upon reorganization, members representing the at-large and District 5 positions will have five-year terms; members representing Districts 1 and 6 will have four-year terms; the member representing District 2 will have a three-year term; the member representing District 3 will have a two-year term; and the member representing District 4 will have a one-year term. The subsequent terms of each member of the Board shall be five years. Each member shall serve until their successor is appointed.
- PAY:** None.
- RESTRAINTS:** No members shall sit on the Board concerning any matter which directly or indirectly concerns their own interests.
- BOARD REPORT REQUIREMENTS:** Transmit findings of investigation to City Council or the City Manager.
- FUNCTIONS:**
- To implement the Code of Ethics adopted by City Council for public officers and employees.
 - To receive and initiate complaints of violations of the Code of Ethics.
 - To hear and investigate complaints and transmit the findings to the Council or the City Manager.
 - To render advisory opinions or interpretations with respect to the application of the Code of Ethics, either on request or on its own initiative.
 - To propose revisions of the Code of Ethics to assure its continuing pertinence and effectiveness.

NEWARK HOUSING AUTHORITY

- AUTHORITY:** Delaware State Code, Title 31, Chapter 43.
- MEMBERSHIP:** Seven members.
- APPOINTMENT:** Four appointments by Mayor; three appointments by Governor.
- TERM:** The terms are for three years with no limit in how many terms a member can serve.
- PAY:** None.
- RESTRAINTS:** All Board members must be residents of the City of Newark with one member being a participant in a program administered by the Authority.
- BOARD REPORT REQUIREMENTS:** Minutes submitted monthly to Council.
- FUNCTIONS:** The Newark Housing Authority’s (NHA) primary function is to provide rental assistance with Federal Funds received from the U.S. Department of Housing and Urban Development (HUD) in administering two Federal Programs within the City limits of Newark, Delaware to qualifying families. The NHA owns and manages rental units offered to tenants who qualify under the Low-Income Public Housing Program and provides Housing Choice Vouchers to eligible participants for use in the private sector. Although both programs have their own set of reporting requirements, the NHA is evaluated annually by HUD to determine ongoing compliance in administering these programs.
- Historical Legislation of Public Housing**
United States Housing Act of 1937
- The Housing Act of 1937 is responsible for the birth of federal housing program initiatives. This act was originally intended to provide financial assistance to states and cities for public works projects, slum clearing, and the development of affordable housing for low-income residents.
- Housing Act of 1949**
- The Housing Act of 1949 established a national policy of “a decent home and suitable living environment for every American family.”
- All other powers and obligations outlined in Title 31, Chapter 43, *Del. C.*
- MEETINGS:** Second Wednesday of each month. Special meetings on call of the chairperson.
- MISSION:** The Mission of the Newark Housing Authority is to provide safe, decent, sanitary housing for low- to moderate-income families, the elderly, and persons with disabilities. The Newark Housing Authority will manage resources efficiently, consistent with the highest ethical standards and free from discrimination. The Newark Housing Authority will seek to empower residents and clients to reach self-sufficiency and to make the transition to non-subsidized housing.

PLANNING COMMISSION

- AUTHORITY:** Newark City Code, Chapter 2, Article VIII, Sections 2-78 to 2-90; Newark City Charter, Section 901; Delaware State Code, Title 22, Sections 701 to 711.
- MEMBERSHIP:** Seven members.
- APPOINTMENT:** One member from each district and one member at-large, subject to confirmation by City Council.
- TERM:** Three-year terms.
- PAY:** None. Reimbursement for actual and necessary expenses incurred while on official business as approved by Council.
- RESTRAINTS:** Members shall be qualified by reason of education, experience and familiarity with the City. Each member shall be a resident of the numbered district from which appointed.
- BOARD REPORT REQUIREMENTS:** On or before October 1 of each year, work program to be prepared for coming fiscal year; to include necessary Planning Commission expenses to cover program to be submitted to City Council. Submit to Council all recommendations and advisements on planning subjects.

Study all applications for approval of land subdivision, conduct conferences and hearings necessary to make such plans acceptable to them. Make recommendations to Council, after considering advice of Planning and Development Director, regarding revisions of Subdivision Regulations.

Conduct public hearings on annexation proposals and make recommendations to Council.

FUNCTIONS:

All questions concerning the location or acceptance of any public place, playground, parkway, street, avenue, highway, square, park, or of the design, acceptance or location of any bridge, viaduct, street or park fixtures or structures, or any public building (including a public library) or works of art proposed to be erected either wholly or partly by public or private funds, and as related to the implementation of the Comprehensive Development Plan, shall be referred to the Planning Commission by the Council for recommendation to Council within a time specified by Council.
