- We have 250 spaces with sensors
- The YTD annual average reset revenue (per space with sensor) is \$298
- Total annual revenue through mid-Nov is \$74,502.28

With this experience noted, and additional sensor purchases in the 2017 Budget we will be in a position to possibly add to the Parking Fund Reserves to fund future projects. Currently \$850,000 is budgeted to be transferred to the General Fund.
